### By Air

The Galileo Galilei airport of Pisa offers a wide range of flights, including direct flights from the United States. The airport is connected with the city via a shuttle bus service run by the company CPT or by a metropolitan train that links it with the Pisa Centrale railway station.

### By Train

Pisa is linked to Rome by high-speed Eurostar trains with a journey time of under 3 hours. For those arriving from airports in Milan, high-speed Eurostar connections take only 3 hours 50 minutes (via Florence or Genoa). The Stazione Leopolda is in walking distance of the Central railway station: We strongly recommend the train over the car, since it is safe, ecological and avoids the worry of driving in city traffic. The walk is only 800 meters and worth it!

### By Car

The area of Pisa is particularly well-served by the road network, and can be reached both via the A11 toll-pay motorway or, for those arriving from the direction of Florence, via the Firenze-Pisa-Livorno highway (SGC FI-PILI), toll free.

# Workshop on eHealth Interoperability: Towards Effective eHealth Interoperability Certification and Conformance Testing

## Introduction

One of the key challenges in the eHealth sector is to establish interoperability between the many IT based systems that need to communicate efficiently and effectively in order to optimally support the provision of health. To ensure interoperability, systems need to be tested and verified against established standards and profiles (conformance testing) and also against each other (interoperability testing).

Successful testing requires the definition of well defined processes and quality management systems supported by an appropriate test tool chain. At this time, the existing testing tools internationally available for this purpose are becoming more and more effective but need to be completed. Furthermore, there is currently no overall approach encompassing the full spectrum of interoperability and conformance testing. Finally, certification and quality labeling can be a mean to express successful testing.

The workshop describes the world of eHealth interoperability and conformance testing not only from the current perspective but also presents a roadmap how the field is about to develop in Europe according to the roadmap established by the HITCH (Healthcare Interoperability Testing and Conformance Harmonisation) project. HITCH is a project funded by the European Commission and will provide the official European Roadmap on eHealth interoperability testing. HITCH involves partners from Europe that are already working at the heart of eHealth interoperability for many years.

## Workshop Speakers

For this workshop, not only experts from the HITCH project partners (see bottom) are presenting their view on the topic but also international experts from the field. Lisa Carnahan, who is working at NIST (National Institute of Standards and Technology) will provide an overview of the testing and certification approach adopted in the USA.
